 - **Directly attending shareholders:** 5 shareholders, representing **1,711,000 shares**, equivalent to **3.46%** of total voting shares.
 - **Authorized shareholders (by proxy):** 9 shareholders, representing **4,232,000 shares**, equivalent to **8.55%** of total voting shares.
